It covers all the key points in the new guideline regarding Symptoms, Diagnosis and Management, and opens by stating that ME/CFS:

"...is a complex, chronic, multi-system medical condition for which the pathophysiology is still being investigated and that symptoms can fluctuate. And that patients may have experienced prejudice, disbelief and stigma."

And that health professionals should take into account the effect that this may have had on:

"...their ability to trust health and social care services; this has also been reported by healthcare professionals who have suffered with CFS as part of long COVID."

The module also emphasises the importance of recognising post-exertional malaise and the removal of graded exercise therapy.

## The module recommends that GPs:

Search your computer system for all your patients with a coded diagnosis of CFS or ME.

Are they all under the care of a specialist clinic? If not, should they be referred?

Consider running a teaching session about this guidance, focusing on diagnosis, primary care management and a review of your local pathways for referral.
